

## 2018 TPMGC MEMBER RENEWAL INSTRUCTIONS

To All TPMGC Members, the following is the information and instructions for renewing your 2018 membership in our club

- The 2018 TPMGC renewal window will be open effective **November 1, 2017 thru December 31, 2017**. On January 1 2018, the window will close. This renewal period affects the vast majority of our Club members, whose membership expires December 31 2017;
- In addition to this E Blast, we will post **these instructions on our website under Membership Information**. Also you will receive at least 2 reminder notices from the SCGA during this renewal period;
- Your Board has approved the following fee schedule for 2018 new and renewal memberships – **City renewals pay \$100; County renewals pay \$200 and all New Members pay \$250;**
- Note: **there no longer is a “late renewal” option, if you do not renew on time, you will need to reapply as a “new member” to reactivate your membership**. City expired memberships will be renewed, but will pay \$250; **County expired renewals will be subject to the County “cap” membership level of 350 (currently there are 387 County members)**. We have started a “wait list” for County membership. There are currently over 15 names on the wait list, any County member who lets their membership expire, will fall to the bottom of the list; you will have no preferential placement on the list;
- If you are on **“auto renewal” you do not need to do anything**, your membership, either City or County will automatically be renewed; \*\*Please see Note below
- If you are not on auto renewal, you will need to go to the following website - <https://membership.scga.org/start/join/?cid=338> and simply follow the on line instructions beginning November 1<sup>st</sup>;
- This year we are asking you to **check the box as to whether you are a City or County resident and also insert (if you have one) your City Resident card number**. This information will be used to “verify” your residence location (City vs County) and that the proper fee has been paid. **Note: you may be asked to provide additional information for this verification and your renewal will be on hold until such time as that information is received by the Membership Chairman;**
- If you have **unpaid “late cancelation or no show” fees** due the Club, your membership will not be renewed until those fees are paid. Please go to TPMGC.org, click on Penalty List and pay any fee due via the process described therein;
- For those members that joined our Club after January 1 2017, your renewal period will be your anniversary date one year from when your membership was approved; you will receive ample notice from SCGA at least 60 days prior to your membership expiration date. You will follow these same instructions to renew at that time.

\*\*If for some reason your auto-renewal fails, you and the club will be notified via email and you will be given the opportunity to renew online. You will be sent two email messages telling you that you are scheduled to be auto-renewed, with nearly all of the auto-renewals scheduled to be processed no later than two weeks before the expiration of your membership. If you receive a failed auto-renewal attempt message, respond quickly and use the link, before December 31<sup>st</sup> or your membership expiration date, otherwise you risk the possibility of a much higher City fee, or hitting the County “cap” referenced earlier.
