- **New format for President's Cup**

144 players would split them into 2 groups of 72 players, each having 36 teams. Each foursome would consist of one team from each group, and they would play against each other for points.

Winners win 2 points, ties are 1 point. The group that won the most points would get paid the same amount at the end equally. 50% of field gets paid. Subsidy requested - \$2500.

The four 9 hole tournaments would consist of 4 ball, alternate shot, match play and medal play. All at net

The players, when they sign up, would sign up in teams of 2. Singles would get assigned to other singles. The same players would play both days

- **Flags can be pulled out now. Bunkers have rakes. How are we playing it?**

Flags in due to TP cups. Action item - Roy to check with TP re: how to play bunkers. Away tournaments – TC to verify prior to outing how to play flags and bunkers.

- **Adjustments needed when Torrey North goes to 17 holes**

Play as 17 hole tournament – no post or give “net par” on 18th hole? Action item- JD and Steve to follow and advise.

- **8 stroke differential (Sorensen)**

Stroke differential? We should play same rules as the SCGA BB of Partners for consistency. Action item - Larry to follow with Marc.S.

- **Update - Pace of Play recommendation (Cincotta, Couillard, Allison, Carter and Huerta)**

Action item - Propose joint meeting with tournament committee on April 13th to review and resolve POP process and potential penalties.

- **Pace of Play metrics from AI**

- **Posting after round – immediate? Any penalty if not done within what timeframe?**

Propose corrections to GG be made no more than 15 minutes after completion of round per time on PofP metrics. For time being, tournament coordinator inquires of any group exceeding 15 minutes to determine what happened. No penalty. Members to be reminded that “any problems with GG’ should be reported to tournament coordinator or board member immediately.

- **Senior Championship and SCGA better ball, all players should play from the same tee. This would put everyone on equal ground.**

- **Weekday SCGA BB Qualifier – 1 for SCGA and 1 for Cup qualifier?**
Weekday BB of partners – flight 1 winners of April 29 and May 27 play each other playoff to determine SCGA qualifier. Club to pay advance tee time expense.
Weekend BB of Partners April 3 to SCGA BB qualifier.
Torrey Cup qualifiers – Weekday – 3 flights each day qualify (6 total), 2 players each, so 12 players qualify for Torrey cup. Weekend –4 flights qualify (8 [players) for Torrey Cup. Total 20 players qualify for Torrey Cup.
**New proposals– Super Senior (65-74) \$65 each net and gross winner.*
Legends – age 75+ \$75 each, net and gross winner.
- **Procedure for member Code of Conduct issues**
Action item - Michael is developing new process for member code of conduct violation. CofC committee (3 or 5 board members) determine action and advise the offending member. Member then has the right to appeal to full board for review.
